You may include any quotes, photos (square or rectangular, and a minimum of 1080px along the short edge), videos, and/or other illustrative content that supports the success story submission.

You may consider using the following elements to help compose your high-quality success stories:

Basic Questions:

- If you are an apprentice, what is your first and last name?
- If you are a sponsor, employer, or training provider, what is your company name and its role with a Registered Apprenticeship program?
- Where is the Registered Apprenticeship program located (i.e., city and state)?
- What industry is the Registered Apprenticeship program a part of (e.g., hospitality, advanced manufacturing, tech, etc.)?
- What is the Registered Apprenticeship occupation?
- If you are an apprentice, why did you pursue a Registered Apprenticeship?
- If you are a sponsor, employer, or training provider, why did you develop a Registered Apprenticeship program?
- What are the most significant benefits gained from this Registered Apprenticeship program?
- If you are an apprentice, what best describes you? (If you are a sponsor, employer, or a training provider who does your program serve?)
 - Young person (ages 16-24)
 - New to the workforce
 - Someone with a barrier to entering the labor market (e.g., experiencing homelessness, returning citizen, etc.)
 - Military service member, veteran, or spouse of a military service member or veteran
 - An older member of the workforce who is leveraging a Registered Apprenticeship to pivot in their career
 - Other (please share)

Sample Questions for Apprentices:

- What is the most surprising thing about your Registered Apprenticeship experience?
- What is one piece of advice you might give to someone considering Registered Apprenticeship as a career pathway?
- How has your Registered Apprenticeship helped you achieve your personal and professional goals?
- How has increased awareness of Registered Apprenticeships through NAW supported your decision to become an apprentice?

Sample Questions for Sponsors/Employers/Training Providers:

- How has the Registered Apprenticeship program contributed to workforce diversity and inclusion goals?
- Describe any measurable improvements in employee retention or productivity since implementing the Registered Apprenticeship program.
- What advice would you give to other sponsors or employers considering starting a Registered Apprenticeship program?
- Please share your thoughts on how the growth of the Registered Apprenticeship ecosystem and increased awareness of Registered Apprenticeship has manifested through NAW over the past 10 years.
