PROJECT PURPOSE:

New Mexico faces a dire shortage of qualified educators across the state, especially in rural areas and other hard-to staff schools and in high-need licensure areas. *Ed Apprenticeships NM* will create a statewide educator preparation ecosystem that aligns and unites existing disconnected efforts in teacher workforce development into education system-aligned pre-

apprenticeships and Registered Apprenticeship Programs (RAP).

The project's pre-apprenticeship development will align with CTE efforts across the state's high schools, developing and strengthening the opportunities for youth to engage in exploration of the education and training career cluster. This pre-apprenticeship will articulate into an associate's degree RAP resulting in licensure as a paraprofessional. That RAP, in turn, will articulate into a bachelor's or post-baccalaureate program that culminates in full teacher licensure.

SUB RECIPIENT ACTIVITIES:

Ten district employers a year will be incentivized as first-time RAP employers to develop RAPs and recruit, hire, and onboard Apprentices. Eight post-secondary institutions will have supports for partnering each year with the new district employers.
